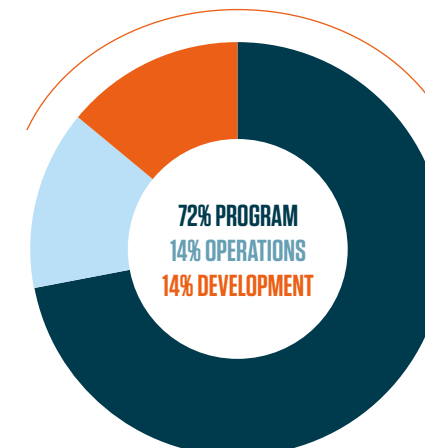
Empower was founded to be different. Our unique, multi-organization structure allows us the greatest flexibility in activity and safety in complying with all federal and state regulations.

Empower Mississippi is the umbrella organization, income tax-exempt under Internal Revenue Code 501(c)4, with Empower Mississippi Foundation, an internal educational trust fund, tax-exempt under IRC 501(c)3, and Empower PAC, a connected state PAC, exempt under IRC 527. Embark, LLC, is a single-member LLC, wholly owned by the foundation.

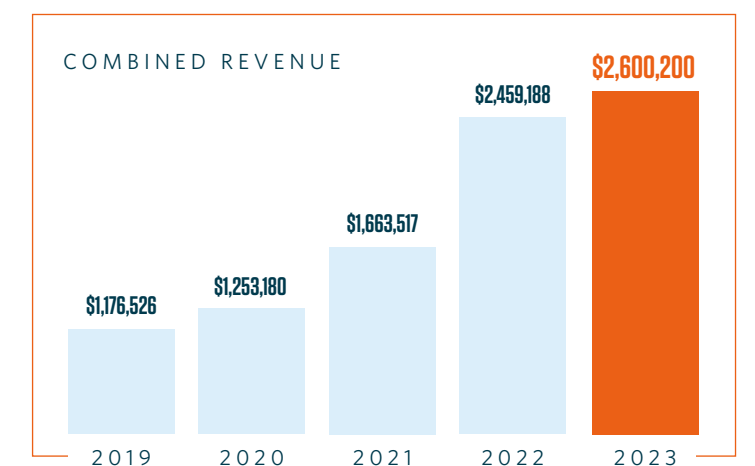

New Schools for Mississippi

Embark, an initiative of Empower Mississippi, is a new schools accelerator supporting founders to open charter school and microschool options across the state.

Embark provides free guidance to leaders who want to start new schools to serve Mississippi students. From ideation and early planning to school development and launch, the journey to opening a new school is full of obstacles that can result in losing momentum. Embark is there to *find, guide, and invest* in new school founders.

EXPANDING MISSISSIPPI'S PUBLIC CHARTER SCHOOLS

Mississippi's public charter school law has been on the books for a decade, yet Mississippi has only 10 charter schools open today. Submitting a successful charter application and preparing to serve students takes approximately three years of planning and hard work.

Embark offers introductory webinars and resources to help anyone interested in opening a charter school in Mississippi understand the state landscape and requirements. In addition, the Embark Fellowship prepares and supports promising charter school founders to submit an excellent charter application to the state authorizer board. Throughout the year-long fellowship, Embark walks alongside each Fellow to build a customized program of support based on the Fellow's unique needs and experience.

In 2024, Embark plans to support two Fellows through Mississippi's annual charter application cycle.



CASE STUDY

A NEW MISSISSIPPI DELTA HIGH SCHOOL IN 2025

Clarksdale Collegiate Public Charter School is a high-quality K-8 charter school in the Mississippi Delta, preparing students "to excel in high school and college by providing rigorous instruction within a structured, ambitious, and jubilant school community."

Clarksdale Collegiate had previously applied to open a high school but had been rejected. With Embark's customized support throughout 2023, Clarksdale's revised application was approved, and plans are underway to open the high school in 2025.

"Embark's tailored support was vital during our planning and application stages," says Clarksdale Collegiate Executive Director, Amanda Johnson. "Thanks to Embark, we will achieve our dream of serving students through high school next year."

MICROSCHOOLS BLOSSOMING ACROSS THE STATE

Microschools are intentionally small educational settings, usually launched by entrepreneurial educators or parents. They are the "modern, one-room schoolhouse," typically offering a multi-age classroom experience that includes opportunities for students to learn flexibly and at their own pace. Since 2020, interest in creating new microschools across the state has exploded as more and more parents seek out a tailored, more responsive educational setting for their children.

The timeline for developing a microschool idea and making progress toward launch depends on experience, context, and other factors. However, one of the attractions of microschools is that they can be planned and opened quickly - generally within a year.

FIVE NEW MICROSCHOOLS OPENING

Through Embark's *Momentum Microgrants* program, which provides microschool founders with financial and planning support, five new microschools have opened or are in the process of opening their doors, and Embark currently has a pipeline of more than 30 potential microschool founders exploring the opportunity through workshops and other events.

In 2024, Embark plans to support the planning and opening of up to 15 new microschools across the state.

EDUCATION FREEDOM IN ACTION

That's the lesson Marcus and Christeen Moffett of Jackson learned early on. With four children attending three different schools and three different school models (private, charter, traditional), the Moffetts are living proof that for children to thrive, they must find the school that is right for them, not just the school that is assigned to them because of their zip code.

The Moffetts' oldest son Taylor, 15, attends St. Joseph's Catholic School, a private school in Madison, where he plays football. Kasey and Kaleb, 11-year-old twin boys, are in the sixth grade at Midtown Public Charter School in Jackson, while 9-year-old Serenity attends Spann Elementary School, her residentially assigned public school in Jackson, where Christeen says she is thriving.

This is what a thriving educational marketplace should look like - each school competing for the chance to serve kids; and parents empowered to make the choice that works best for them.

Kasey and Kaleb attended Spann Elementary School, and as middle school approached, Christeen began exploring her options. After looking at several schools in the area and not finding what she was looking for, Christeen decided to look at a charter school. She met with Kevin Parkinson, principal at Midtown Public Charter School, to see if this school would be the right choice for Kasey, who has dyslexia.

"He listened to my concerns and explained what they offered. It was invaluable to me as a parent," Christeen says. Finding Midtown was a "breath of relief."

The Moffett children are flourishing because their parents chose educational settings that specifically meet the needs of each child.

"As a parent, you know your child best, and it's important to have options for school," says Christeen. "We need options in life because one size doesn't fit all."

This philosophy drives Empower Mississippi's education focus. Education freedom is about empowering parents - the adults who know their children best - to access the academic setting that best suits the child's individual needs. The goal isn't to support one form of school over another, but to support every child in achieving their full potential.

"Our ultimate goal," Christeen says, "is for our children to get through school and to be productive citizens. We've been through times where I've stressed about my son's grades or the school testing, and Marcus reminds me that that is not the goal. The goal is for them to be happy, productive citizens in life."

EMPOWERING OUR ECONOMY

THE DIGNITY OF WORK

At Empower Mississippi, we believe that work can provide purpose, identity, and a sense of belonging. Work helps us care for ourselves and our families. It provides a path to help improve lives and communities. Almost all people are capable of making meaningful contributions to their community and their own lives, and work can be a source of great accomplishment and personal fulfillment.

That is why Empower Mississippi proactively works to expand economic opportunity to more of our neighbors to help make the Magnolia State the most job-friendly state in the nation.



The State of Work in Mississippi

We all know Mississippians work hard. Whether it's a single mom in the Delta working two jobs to make ends meet for her and her kids, or a young man from the Gulf Coast piecing together a living wage through multiple gig economy jobs, Mississippians are no stranger to hard work to get by.

But when it comes to our state's overall job market, compared to the rest of the country, we have a lot of work to do.

Our state's unemployment rate hovers near 3%, one of the lowest in the nation, meaning most Mississippians who want a job are able to find one. **But, Mississippi also ranks last in the nation in labor force participation for residents 16-years-old or older.** This tells us we have a historically high number of Mississippians who are of working age, but are no longer looking for work. The reasons for this are multifaceted, but chief among them are our state's relatively low levels of education attainment and our world-leading incarceration rate.

ECONOMIC MOBILITY FOR ALL

We need more Mississippians in the workforce, and to achieve this, we must invest in education choice options that prepare the next generation of workers for success beyond the classroom.

But beyond preparing Mississippians to enter the workforce, we must also foster an environment where businesses can thrive and create job opportunities. This includes reducing bureaucratic red tape and supporting entrepreneurship at the grassroots level. It also includes tapping into an often-overlooked pool of candidates: those who are re-entering society post-incarceration (a key focus of our Justice

initiatives). Historically, marginalized communities, including people with disabilities, veterans, and those with criminal records, often faced barriers to employment. By creating pathways for these individuals to enter (or re-enter) the workforce, we not only uplift them, but also enrich our communities with diverse perspectives and talents.

Building a society where all Mississippians can participate in meaningful work is not just about creating jobs; it's about creating the right kind of jobs. Mississippians don't just want to work; they want to engage in work that aligns with

their passions, skills, and aspirations. This means that as we think about workforce development, we must also think about how to match individuals with opportunities that allow them to shine, and our education system must be structured to align with the needs of the business sector, today and into the future.

Work is more than a means to an end. It's a pathway to dignity, purpose, and community. Empower Mississippi is committed to ensuring that this pathway is accessible to all in our state. Because when we uplift our workers, we uplift Mississippi.

EMPOWERING BUSINESS

In the 2023 Legislative Session, Mississippi enacted a simple tax reform measure that will benefit every business and worker in the state. **EMPOWER MISSISSIPPI LED THE ADVOCACY CAMPAIGN** for this “full expensing” policy, which garnered unanimous bipartisan support, and national headlines from the likes of National Review. Here are some excerpts from their article.

MISSISSIPPI'S NEW TAX MODEL CAN WORK FOR AMERICA

Full expensing can help secure a domestic home for more of America's critical supply chains.

In a rare feat of bipartisan tax reform, Mississippi lawmakers have begun addressing the pressing needs of the post-pandemic economy. On March 27, Governor Tate Reeves signed H.B. 1733 into law after it cleared both legislative chambers unanimously. Sponsored by Representative Trey Lamar and Senator Chris Johnson, the new law creates full expensing for capital investments in research, experimentation, machinery, and equipment in the Magnolia State.

Other state legislatures and Congress should take notes. Full expensing addresses two problems facing the post-pandemic American economy: the need to re-shore critical supply chains and the need to protect business capital investments from the ruinous effects of inflation. Regardless of political affiliation, people concerned about securing America's vital supply chains and leading in the global economy should support the implementation

of full expensing in both state and federal law...

...Full expensing enables businesses to immediately deduct the entire cost of capital expenditures from taxable income, rather than spreading out those deductions over years or decades. This simple change unlocks surprising investment and growth...

...The good news is that Mississippi lawmakers did not invent this policy out of the blue. They simply made permanent a tax policy that used to be a part of federal law... Moving forward, other state and federal budget writers should take note of Mississippi's full-expensing program and implement similar measures. If more states and the federal government get on board, the U.S. will attract vital capital investments that lead to job creation, wage growth, economic expansion, and a secure domestic home for more of America's critical supply chains.

BRIAN AND MARIE SANDERSON

EMPOWERING LEADERSHIP, SERVICE, AND PHILANTHROPY

For Brian and Marie Sanderson, service to their community, state, and country is a central value and a core part of their family life. It's that spirit of service and positive impact that led them to Empower Mississippi, where they have been generous supporters of our work for several years.

Both Mississippi natives, Brian and Marie met in the aftermath of Hurricane Katrina. "I worked with Senator Cochran and Governor Barbour on recovery efforts, and Brian served as General Counsel to the Recovery Commission," Marie told us.

Fast forward almost fifteen years to 2020, and Brian and Marie once again felt called to step up during a time of dire need. In response to the COVID-19 pandemic, they launched Mississippi 30 Day Fund, offering Mississippi small businesses up to \$3,000 in emergency forgivable loans.

"The loans were designed to be quick, easy, and free of red tape as small business owners worked to keep employees onboard and operations running," Brian said.

The Sandersons' focus on common sense solutions inspires them both in business and in their philanthropy.

"We believe in measurable outcomes," Marie said. "Everything we do as business owners involves measuring our success and deliverables for clients. We review our nonprofit giving through the same prism, and the return on investment we receive by investing in Empower Mississippi is exceptional."

Marie began her career on Capitol Hill in Washington, DC, after graduating from

Mississippi State University. Returning to Mississippi, she worked with Governor Haley Barbour's administration and then the Republican Governors Association. Today, she is the founding partner in a national public affairs practice, where she focuses on public policy advisory and strategy.

Brian is the founder and president of Three Oak Group, a government relations and public policy consulting firm that provides

Their impressive government and private sector experiences give them each a unique perspective on how to solve Mississippi's most challenging issues, and they view Empower Mississippi as central to that goal.

"Empower is a convening place for people who share the same values and goals," Marie said. "It's also an incubator and distributor of how ideas can become policy for Mississippi across numerous public policy areas."

"Our hope is to see Empower Mississippi grow and grow," Brian added. "A strong and effective Empower Mississippi will mean a stronger, fairer, more prosperous Mississippi for all."

key services for businesses, advocacy organizations, political campaigns, and public policy think tanks. Previously, Brian served in leadership roles with the Republican Governors Association, the Republican Attorneys' General Association, and on the senior staff for Governor Barbour's administration.

BUILDING A FAIRER SYSTEM



Empower Mississippi led the effort to bring continuity of representation to our judicial system.

A years-long effort, led by Empower Mississippi, resulted in an important rule change this year that makes our state's criminal justice process fairer for everyone.

States are entrusted under the Constitution to make attorneys available to defendants. Most states manage public defenders through a central office, but Mississippi handles the appointment of public defenders at the local level, with individual judges assigning cases to attorneys. This system often results in a gap in counsel known as "the dead zone." One attorney is appointed to represent a defendant for a preliminary hearing and then another attorney is appointed before trial. In effect, this means that

there is a lengthy period when defendants have no counsel to protest excessive bail or move a case along to trial.

The MacArthur Justice Center, which has conducted extensive record requests on Mississippi's jails, said that based on their findings, approximately 47% of detainees in Mississippi county jails had been there for more than three months. "More than 1,000 have been detained for at least nine months, and 731 have been stuck in county jail for over a year," according to MacArthur.

In some cases, people who could not afford an attorney or assigned bail have waited multiple years without an

CASE STUDY

Duane Lake was arrested in 2015 on the very serious charge of double homicide. He consistently denied the accusation, and was not indicted until 2017, at which time he received counsel. He was finally tried in 2021 and was acquitted by a jury of his peers after spending six years in jail, losing his wife, children, and career.

Continuity of counsel will lead to more efficient proceedings- both convictions of the guilty and acquittals of the innocent; both of which are in the interest of the accused and the state.

indictment. It is an egregious miscarriage of justice that someone could face the deprivation of liberty for so long without a trial and conviction.

In 2022, Empower Mississippi filed a motion with the state's Supreme Court to change the procedure for appointing public defenders to ensure that criminal defendants have continuity of representation to defend their rights throughout criminal proceedings.

In direct response to our efforts, this past April, the Court adopted new language for Mississippi Rule of Criminal Procedure 7.2 to ensure this critical safeguard for every Mississippian.



BUILDING COALITIONS

Throughout 2023, Empower Mississippi convened dozens of workshops, seminars, meetings, and discussion groups with our Ambassadors from across the state, focused on a myriad of issues related to Education, Work, and Justice.

We know that meaningful change begins with community engagement and action – and that’s what the Empower Mississippi Ambassador Program is all about. We empower concerned citizens by providing a platform for them to tell their stories and engage with lawmakers to bring about change.
